The often complex texts typically cover political, legal, economic, financial, scientific, and technical subjects related to the EU's activities. You may also work on localising communication materials or subtitling. These duties require extensive use of specialised IT tools.

To apply, you must meet the following requirements:

- Be an EU national and enjoy the full rights of an EU citizen.
- Have completed university studies of at least three years, attested by a diploma awarded by 10 April 2025. No professional experience is required.
- Have knowledge of at least three of the 24 official EU languages, as indicated in the table below.
